MARKET UPDATE

IBPA Sukuk Index (SBIX) increase 0.091% in February. Indonesia 10years sharia government bond yield (PBS025) increase by 15.6bps to 7.0775%. The domestic bond yields are supported by onshore banks, foreign investors, insurance and pension funds. the Rupiah exchange rate is quite stable during the month and become the reason Bank Indonesia maintains its benchmark rate in February 2023 after raising 225 bps to 5,75%. Bank Indonesia has many instruments to maintain exchange rate stability in the current situation. Based on DMO bond flow data as of Feb 28. Foreign ownership recorded at 2,63% of the outstanding and outflow of Ro3.68th YTD.
